i. <u>Board Policy 6175 – Harassment, Discrimination and Misconduct</u> (First Reading)

VP Koslow Martin presented the first reading of Policy 6175, a revised harassment, discrimination and misconduct policy that incorporates updates to Title IX as mandated by the Department of Education, effective August of 2024. Notable changes include the shift from "sexual harassment" to "sexbased harassment," expanding protections to include pregnancy-related accommodations.

### **B. ACTION EXHIBITS:**

i. Amendment to Loyola University Health System Agreement

Ty Perkins announced the consolidation of multiple Loyola-affiliated hospital contracts, including MacNeal, Loyola, and Gottlieb, into a single agreement under the MacNeal contract. This unified contract will support all Triton health career programs, streamlining operations and ensuring consistency.
